1. PRIVACY AND SECURITY POLICY

Haven Yonder Global Ltd (hereinafter referred to as "We, "us", "our" or "Haven Yonder") is a company incorporated under the laws of the British Virgin Islands and acts as a Business Management Consultant. We help organizations navigate complex financial regulations, implement robust risk management strategies, and achieve full compliance with confidence.

2. COMMITMENT

Haven Yonder is committed to protecting the privacy of all personal information obtained from clients, visitors to our website, and any other individuals with whom we interact. Haven Yonder will only use your personal information in accordance with this Privacy and Security Policy the applicable data protection legislation, and relevant international privacy standards.

3. WHY DOES HAVEN YONDER COLLECT PERSONAL INFORMATION?

You also consent to Haven Yonder transferring your personal information outside of the British Virgin Islands where this is necessary for Haven Yonder to fulfill its contractual obligations to you. Please note that Haven Yonder only transfers personal information to organisations outside British Virgin Islands after assessing the organisation as having appropriate controls and safeguards in place to protect your personal data.

6. WHO MAY HAVEN YONDER DISCLOSE THIS INFORMATION TO?

Haven Yonder may be required to provide your personal information to the regulator and government bodies from time to time. Haven Yonder may also disclose your personal information to:

- financial institutions and other similar organisations that it deals with in the course of its corporate activities, or those that are nominated by you;
- external service providers and professional advisers (which may be located overseas) that provide services to Haven Yonder;
- any organisation at your request or any persons acting on your behalf, including your financial adviser, broker, solicitor or accountant;
- any third parties where this is necessary to process a transaction or provide services which you have requested; or any authority to whom Haven Yonder is required to disclose such information by law. Please note that Haven Yonder does not sell or provide your personal information to third parties for marketing purposes.

7. UPDATING YOUR INFORMATION

You may inform Haven Yonder at any time that your personal details have changed or that you wish Haven Yonder to delete personal information we hold about you by contacting us via web form available at our website. Haven Yonder will change or delete your personal information in accordance with your instructions, except to the extent that we are required to hold your personal information for regulatory or legal purposes, to provide you with the services you have requested or to maintain adequate business records.

However, without that information, Haven Yonder may be unable to open an account for you or to provide you with the requested services or information. Under data protection legislation, you have (subject to certain exceptions) the right to obtain copies of any personal information which Haven Yonder holds about you and to inform Haven Yonder of any inaccuracy.

We may charge a nominal fee to cover the cost of verifying the application and locating, retrieving, reviewing, and copying any material requested.
